i.Disaster Risk Management and Climate Change.

ii.Small and Medium Industry.

iii. Women and Children Rights and Protection.

iv.Innovation and Knowledge Management.

The Secretariat does not look at the South-South and Triangular Cooperation by Indonesia as merely an obligation by to carry out a mandate or pledge to Colombo Plan, but a commitment to a long-term strategy by Indonesia to introduce creative new ideas relevant to inter-country emerging needs and exchange of solutions and knowledge in international platforms and also as a means to introduce good innovative practices.
